Title: The role of public participation and stakeholder dialogue in water

management - Good cases of public information and consultation under

the WFD (Art. 14)

The European Environment Agency (EEA) seeks a service provider able to assist in the analysis of good cases of public participation and stakeholder dialogue in the context of the first round of River Basin Management Plans (RBMPs) under the Water Framework Directive (WFD).

## Type of contract:

## Description of the services to be procured:

## Rationale:

The 2012 synthesis report highlights that in order to ensure effective implementation of water-related policies, integration between the different levels of administration (local, river basin district, national and EU) is indispensable. The cooperation of different levels of administration must be completed by a 'horizontal' integration across water-using sectors such as between relevant stakeholders in areas like agriculture, energy, and transport. Healthy water ecosystems can only be secured through a wide participatory dialogue of all stakeholders and the public involved.

Hypothesis: 'Better public participation leads to better plans, and to better implementation of plans'. Effective public participation and cooperation between different stakeholders leads to better implementation of measures.

## Tasks:

Practical examples where the implementation of Article 14 constructively contributed to a better water management, and more consistent and possibly more effective measures, should be analysed on the basis of the  $1^{\rm st}$  River Basin Management Plans, which have been reported in 2010-2012 by Member States.

The outcome of the contract is going to under pin this rationale in close cooperation with a complementary task conducted by the European Topic Centre on Inland, coastal and marine waters (ETC/ICM). The ETC will work in the beginning of the year on the basic background and setting of the project, developing criteria and basic questions to analyse the plans and set already a proposal of possible good cases.

The project should then on this basis conduct interviews and a more thorough analysis of the processes, outcomes, advantages and problems in the public participation and stakeholder dialogue in some specific River Basin Districts.
