5	MB adoption of Single Programming Document (SPD) 2021-2023 including (1) EEA Annual budget 2021 and (2) financing decision on ETCs for 2021	The Bureau advised the MB to adopt the Single Programming Document 2021- 2023, the EEA budget for 2021 and the financing decision on European Topic Centres for 2021. Due to the likely delay in the adoption of the overall.EU budget 2021, the Bureau advises to launch a MB written procedure to request a deviation to the provisional 12 <sup>th</sup> scheme for the EEA budget 2021, as foreseen in the EEA Financial Regulation.	The delayed approval of the EU budget for 2021 by the budgetary authorities would in principle mean that EEA would have to (i) fall back ad interim to the 2020 budget and (ii) to freeze the establishment table to the 2020 level and (iii) could commit only provisional 12 <sup>th</sup> of the budget on a monthly basis until the new EU budget 2021 is approved . Consequently, the limits on commitments would make it difficult to start ETC contracts and to pay the rent for the EEA building, hence the recommendation to request a deviation to the provisional 12 <sup>th</sup> scheme via MB written procedure, as foreseen in the EEA Financial Regulation. The MB adoption of the EEA budget for 2021 remains a requirement regardless of the timing of the adoption of the EU budget for 2021.
