Record of proceedings

The Chair opened the meeting by welcoming the Bureau members and guests.

ITEMS 1-2 FOR DECISION

Item 1 Adoption of draft agenda

The Bureau adopted the agenda (Doc. EEA/BU/69/01 REV) without changes.

Item 2 Adoption of the 68th Bureau minutes, 2 February 2016

The minutes (Doc. EEA/BU/69/02) were adopted without changes and have been made available on the Forum.

With reference to the minutes, the Greek representative requested an update on the question of the environmental consequences of immigration into the EU. The Executive Director responded that the issue had been raised with the Network of Environment Protection Agencies, but that none of the EPAs seemed to be addressing the issue at the present time. No clear link with EU environment policies had been identified.

The member nominated by the European Parliament informed the Bureau that there were two major conferences in Brussels and in Thessaloniki on immigration, with Commission participation. There was thus growing EU involvement in the issue.

ITEMS 3-4 FOR INFORMATION

Item 3 Attendance at Bureau meetings (oral)

In the light of the decision to cancel the meeting on 17 May due to the unfortunate lack of a quorum, the importance of all members attending Bureau meetings was reemphasised. It was agreed not to propose to the Board to change the present rule that substitutes are not allowed,

and it was recognised that the use of videoconferencing could only be relevant in exceptional circumstances if a single member is unable to attend.

All members confirmed their availability for the next meeting on 4 October apart from the Commission representative, who would no longer be a Commission representative on the Board due to a change of responsibilities in DG Environment.

Item 4 Update DG Environment: Evaluation of the EEA/Eionet Regulation (oral)

The Commission representative gave a brief update on the state of play concerning the evaluation, highlighting that the members of the EEA Management Board were in the process of being consulted on the draft roadmap for the evaluation.

The Bureau took note of the update, recognising that the item would be discussed with the Board later in the day.

ITEMS 5-6 STRATEGIC ORIENTATION/FOR GUIDANCE

Item 5 Resource outlook and implications for EEA work programmes

Referring to document EEA/MB/76/07, the Bureau welcomed the initiative by EEA Management to raise the issue of present and likely future resource constraints on the work of the Agency in a timely and structured way with the Bureau and the Board.

Members recognised that, though the evaluation and possible revision of the EEA/Eionet Regulation held some hopes for improvements in the future, the trend of declining resources was unlikely to change fundamentally in the next few years under the present legal framework and with the present political priorities in Europe. It was therefore necessary to adopt a strategic approach towards the evaluation process while at the same time facing up to the reality of the constraints of the next few years.

In the latter context it was recognised that the scope for further efficiency gains was limited, and that there would be a growing need to set priorities and to be very cautious in accepting requests for new work. This applied in principle to requests from the Commission, member countries or the European Parliament. It was vital that the quality of the work of the EEA was in no way compromised by spreading resources too thinly in an attempt to respond positively to all requests.

Though several highlighted the fact that resources are constrained at the national level also, it was felt that there might be a possibility of more support from countries in the form of National Experts.

In the context of setting priorities and the need to focus even more on the core tasks of the agency, it was emphasised that these involve assessment and indicator work as well as data collection and management. It was also pointed out that the Commission-led Monitoring and Reporting Refit exercise could perhaps lead to a reduction in the work associated with managing data flows and databases.

While finding the background paper very useful as a means to initiate the debate, it was recognised that real priority-setting requires analysis and discussion at a greater level of detail ('granularity') than present in the paper.

On specific issues the Executive Director clarified:

(in answer to a question from the Chair of the Scientific Committee), that the agency
would continue to work on urban issues in relevant fields such as air pollution, noise
and climate change adaptation, but was not able to respond to the overall urban
agenda being developed by DG REGIO;

• (in answer to a question from the Commission representative) that resource implications and expected benefits from the Environmental Knowledge Community were factored in.

The Bureau concluded that the discussion in the Bureau and the Board later on the same day was very useful to raise awareness of the issue, while the more specific consequences of the resource constraints should be addressed in the annual work programming processes.

Item 6 Representation of non-EU countries at Bureau meetings

As several of the non-EU member countries were in the process of replacing their members of the EEA Management Board, it was agreed to postpone the issue until later in the year.
