AWP 2020: Adoption	Adoption of SPD 2020–2022 The Bureau adopted the Agency's Draft SPD 2020-2022 (¹), and requested the EEA to submit it to the EU Institutions (²) (Decision EEA/BU/2019/002) Budget uncertainties - The Executive Director highlighted that the EEA draft programming in the Draft SPD 2020—2022, is based on the budget assumptions received from the Budget Authorities, and does not take into account potential implications of budget uncertainties (e.g. Brexit and MFF 2021—2027). - The Bureau recognised the draft status of the SPD 2020—2022; and agreed to the need to revise the Draft SPD 2020—2022, including potential budget scenario's and EEA priorities; if the EEA budget from 2020 would be revised by the Budget Authorities.	Further process and timelines: The Bureau asked EEA to adjust the Draft SPD 2020—2022 a) to highlight its context regarding the budget uncertainties, and b) to edit typographical issues in the Draft SPD 2020—2022, following feedback received from the Commission. The edited Draft SPD 2020—2022 will be annexed to the Board decision. Feedback on the draft SPD2020—2022 will be invited from the European Commission, Parliament, EEA Scientific Committee and Eionet through a consultation starting by the end of January 2019. The final SPD 2020—2022 is foreseen to be adopted by the Board in December.
