

Opinion by the EEA Scientific Committee on the recruitment of scientific staff in 2015

In 2015, recruitment procedures were completed for a Project Manager within IT software development. Furthermore, internal mobility procedures for a Head of Group for the area of Biodiversity were completed with a successful outcome (appointment/reassignment).

In addition to this, the Agency completed recruitment procedures for four scientific contract agents to work as Project Managers in the areas of Water industries and pollution; Biodiversity indicators; Press Officer / Environmental Journalist; and Regional marine state of the environment assessments. Furthermore, recruitment procedures were completed for three Project Managers and one Project Officer under the Copernicus project. Finally, recruitment procedures were completed for two secretaries; one in the Integrated environmental assessments Programme; and one in the Air and climate change Programme.

The Scientific Committee notes that the scientific expertise needed was sufficiently represented in the Selection Committees for the above posts. The names of the Selection Committee Members for the above posts are attached to this paper.

Three National Experts initiated their secondment in 2015 following three separate Calls for interest within the area of Climate change impacts and vulnerability – natural hazards; Copernicus services; and Industrial emissions. Selection procedures for a further National Expert for the EPA Network secretariat were finalised. A Call for National Experts 2015 covering 9 profiles was launched by the end of the year.

The Scientific Committee continues to play an important role in the EEA recruitment process through raising awareness of the open EEA posts to qualified candidates with acknowledged scientific basis and also by participating in the selection processes.
