

Opinion by the EEA Scientific Committee on the recruitment of scientific staff in 2016

In 2016, recruitment procedures were completed as follows:

Temporary agents

A Project Manager within the area of Air quality reporting and assessment has been recruited and two Project Officers have been recruited within the areas of Human Resources and Procurement respectively. Procedures have been finalised for a Project Manager within the area of Industrial pollution. Furthermore, procedures are ongoing for a Project Officer within the area of Climate change mitigation monitoring, reporting and verification.

Following internal mobility procedures, three Heads of Group have been appointed for the areas of Water and marine; Eionet coordination and international cooperation; and Foresight and sustainability, and a Project Manager has been appointed within the area of Strategic planning, governance and institutional relations.

Contract agents

In addition to this, the Agency completed recruitment procedures for nine scientific contract agents in Function Group IV – a Press Officer/Environmental Journalist, an Editor, a Project Manager for Regional marine state of the environment assessments, a Project Manager for Chemicals, environment and human health, three Project Managers for Sustainability assessments and two Project Managers for Transport and environment reporting). Procedures are being finalised for further five Project Managers within the areas of Climate change adaptation; Web and online communications; Data management and INSPIRE; and Press Officer/Environmental Journalist and procedures are ongoing for two Project Managers within the areas of Agriculture and agro-ecosystems; and Soil assessments. Two contract agents in Function Group III have been recruited within the area of IT system administration support and Financial assistance. Three contract agents in Function Group II have been recruited. A new procedure for secretaries in Function Group II was launched towards the end of the year.

Following the signing of the Copernicus delegation agreement, four contract agents in Function Group IV have been recruited.

Following the signing of the ENI/IPA project, three contract agents in Function Group IV have been recruited; one Project Manager for ENI South and two Project Managers for ENI East. Procedures for a further Project Manager for ENI East are ongoing. Two contract agents in Function Group III have been recruited.

The Scientific Committee notes that the scientific expertise needed was sufficiently represented in the Selection Committees for the above posts. The names of the Selection Committee Members for the above posts are attached to this paper.

National experts

Five National Experts have been seconded for the areas of EPA Network secretariat; INSPIRE and data reporting; EUNIS support; Air pollutant emissions mitigation and Web content management. Secondment procedures are ongoing for a further National Expert within the area of Environmental information on hydromorphology and floods. A new Call for expression of interest 2016 was launched and procedures are ongoing for National Experts within 11 different areas.

Scientific Committee

Following the Call for expression of interest for experts to be appointed members of the Scientific Committee, selection procedures were finalised for the areas of Socio-technical systems; Socio-

ecological systems; Sustainability; and Data. 9 new members have been designated to the Scientific Committee following the December Management Board meeting.

The Scientific Committee considers that the recruitment procedures undertaken for scientific staff in 2016 were overall aligned with the 2014-2020 Multi Annual Work Programme.

The Scientific Committee continues to play an important role in the EEA recruitment process through raising awareness of the open EEA posts to qualified candidates with acknowledged scientific basis and also by participating in the selection processes.
