Kongens Nytorv 6 (KN6) and Kongens Nytorv 8 (KN8), 1050 Copenhagen K, DENMARK, linked together through corridors on the ground and first floors. The total surface area of the premises is approximately 9 900 m². Currently, approximately 220 persons are working at the EEA.

The EEA has an access control/burglary alarm and an RVS system in place that shall be maintained by the contracted service provider. An automatic fire alarm shall be maintained by the contracted service provider through Dansk Brandteknik A/S. Annex 7 to the tender specifications provides a detailed description of the security systems and equipment.
