To that effect tenderers are required to submit a declaration of honour (see Annex 1 to the tender specifications) in accordance with Article 134 of Commission Regulation (EC, Euratom) No 2342/2002 of 23.12.2002, OJ L 357/1 as last modified by (EC, Euratom) No 487/2007 of 23.4.2007, OJ L 111/13. Under the same provision,

the tenderer to whom the contract is to be awarded will be required to produce evidence confirming the prior declaration unless this obligation is waived by the contracting authority.

**III.2.2) Economic and financial capacity:**

Information and formalities necessary for evaluating if requirements are met: Proof of economic and financial capacity may be furnished by (1 or more of) the following documents:

- (a) appropriate statements from banks or evidence of professional risk indemnity insurance;
- (b) the presentation of balance sheets or extracts from balance sheets for at least 2 years for which accounts have been closed, where publication of the balance sheet is required under the company law of the country in which the economic operator is established;
- (c) a statement of overall turnover and turnover concerning the works, supplies or services covered by the contract during a period which may be no more than the last 3 financial years.

If, for some exceptional reason, which the contracting authority considers justified, the tenderer or candidate is unable to provide the references requested by the contracting authority, he may prove his economic and financial capacity by any other means which the contracting authority considers appropriate.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal.

2. Junior consultants: a minimum of 2 CVs documenting a minimum of 2 years' experience each as a junior consultant in the field of business economics (microeconomic and investment calculus, and cost-benefit analysis) including writing skills in English;

- (b) a list of the principal similar services provided in the past 3 years, with the sums, dates and recipients, public or private;

(c) a description of the measures employed to ensure the quality of services, and a description of the firm's study and research facilities;

(d) an indication of the subject and the scope of the contract which the tenderer may intend to subcontract;

(e) a description of the tenderer's environmental policy.
