CORINE Land Cover (CLC) is the primary Land Cover/Land Use (LC/LU) database of the European Environment Agency (EEA), a homogeneous LC/LU database available covering all member states. CLC2012 is the fourth such inventory in a time series, following CLC1990, CLC2000, and CLC2006. CLC is mainly used for reporting, indicator development and modelling. This contract addresses the coordination and production of CLC for non-EU countries: Turkey.

The purpose of this open call for tenders is to establish a framework service contract with an economic operator who can provide services to update the previous inventory (CLC2006) to the reference year 2012 by producing a land cover change map (CLC_Change2006-2012) and the CLC2012 status map.
