To that effect tenderers are required to submit a declaration of honour (see Annex III to the tender specifications) in accordance with Article 134 of Commission Regulation (EC, Euratom) No 2342/2002 of 23.12.2002, OJ L 357/1 as last modified by (EC, Euratom) No 478/2007 of 23.4.2007, OJ L 111/13. Under the same provision, the tenderer to whom the contract is to be awarded will be required to produce evidence confirming the prior declaration unless this obligation is waived by the contracting authority. Legal capacity — tenderers are requested to prove that they are authorised to perform the contract under national law, as evidenced by inclusion in a trade or professional register, or entry in the VAT register.

Tenderers shall provide an identification sheet (see Annex IV to the tender specifications) duly filled out and signed, a copy of inscription in a trade register, where applicable, and a copy of inscription in VAT register.

- (c) a statement of overall turnover and turnover concerning the works, supplies or services covered by the contract during a period which may not be more than the last 3 financial years.
- If, for some exceptional reason which the contracting authority considers justified, the tenderer or candidate is unable to provide the references requested by the contracting authority, they may prove their economic and financial capacity by any other means that the contracting authority considers appropriate.

- (d) of a description of the technical equipment, tools and plant to be employed by the firm for performing a service or works contract such as a description of the network-management facilities, customer support centre, contact point and customer report tools in place at the tenderer's;
- (e) of a description of the tenderer's environmental policy (including for example, confirmation of FSC certificate, 'Svanemærket', or equivalent);
- (f) if subcontracting of certain services is envisaged, the tenderer shall provide a description of the services to be subcontracted and their scope.
