2	Follow-up to the 110th Bureau meeting (7 May 2025)	The Bureau agreed to reflect on the adequate duration of the silent procedure for MB and Bureau decision lists. The Bureau took note of the clarification of the Chair on the purpose of the silent procedure, which is to enable the inclusion of missing points to decision lists, but not to enter a redrafting exercise.	The Bureau tested the silent procedure with the decision list of the 7 May meeting. The Chair considered that the initially suggested duration of 15 calendar days was slightly too long. Some international organisations have 72 hours silent procedures on their meeting outcomes.		
		The Bureau took note of the proposal from the Chair to initiate the review of the MB and Bureau rules of procedure towards the end of 2025 or early 2026, with a discussion at the January 2026 Bureau meeting. This discussion would include the suggestion to invite environmental and industry NGOs to observe MB meetings in the future.	Bureau decision lists for meetings taking place back-to-back with MB meetings are not subject to the silent procedure, as they need to be finalised by the time of the MB meeting.
