## Introduction

This note lists the changes in emissions and background information from the CRF submission to the UNFCCC on the 17.03.2004. The changes are described according to CRF table, IPCC sector, and pollutant. The changes to the CRF have been made as a result of the comments made by the UNFCCC (supplied via Roberto Acosta Manager Inventories subprogramme) on the 06.05.2004 to Sarah Hendry (UK Defra, GAD). The changes made to the CRF have not altered the national total emissions.

Cell D30 in Table1s2 was not correctly linked to Table1.B.2 cell K32. This has now been corrected and the two values indicated agree. The change was only required for the year 2000.
