

# BWD Report For the Bathing Season 2016 Slovakia

The report gives a general overview of information acquired from the reported data, based on provisions of the Bathing Water Directive<sup>1</sup>. The reporting process is described below, as well as state and trends of bathing water quality in Slovakia.

## 1. BWD reporting in the season 2016

In 2016 bathing season, 33 bathing waters have been reported in Slovakia. For each bathing water, five groups of parameters have been delivered<sup>2</sup>:

- *identification data* including name, location, geographic type of bathing water and availability to bathers;
- seasonal data including season start and end, national quality classification in present season, potential management measures and changes in quality;
- *monitoring results* disaggregated numerical values of two microbiological parameters – intestinal enterococci and Escherichia coli (also known as E. coli), recorded at each water sample taken;
- *abnormal situation periods* periods of unexpected situations that have, or could reasonably be expected to have, an adverse impact on bathing water quality and on bathers' health; reporting is optional;

Bathing waters of Slovakia in 2016

• *short-term pollution periods* – identifiable events that adversely affect water quality by faecal contamination; reporting is optional.

The authorities of Slovakia report data according to the new BWD (2006/7/EC) since the season 2008. The data for the season 2016 were delivered to the European Commission by **21 December 2016**.

Altogether, **33 bathing waters** have been reported – 0.2% of all bathing waters in Europe. Out of all bathing waters in Slovakia, none have been newly identified in 2016 season. All bathing waters in Slovakia are inland. **214 samples** were taken at bathing waters throughout the season – 6 per bathing water on average.

Maximum bathing season period was from 25 May to 16 September, with a maximum season span of 111 days<sup>3</sup>. Season duration varies depending on the bathing water.

## 2. Assessment methodology<sup>4</sup>

During the bathing season, water samples are taken and analysed for two bacteria, *Escherichia coli* and intestinal enterococci which may indicate the presence of pollution, usually originating in sewage, livestock waste, bird faeces etc. The results of the analysis are used to assess the quality of the bathing waters concerned and to provide information to the public on the quality of water in the bathing sites concerned.

The monitoring requirements under the Directive are:

- taking a pre-season sample (taken shortly before the start of the bathing season) <sup>5</sup>;
- a minimum of four samples per season<sup>6</sup>;
- a minimum of one sample per month<sup>7</sup>.

If these rules are satisfied, the bathing water is categorised as 'sampling frequency satisfied'. If not all monitoring requirements are fulfilled the bathing water is categorised as 'not enough samples'. 90.9% of bathing waters met the described monitoring requirements set by the Directive, while the rest did not satisfy monitoring requirements for different reasons: being new; having changed environmental conditions that might affect water quality classification; closed; not monitored due to legal issues, physical inaccessibility to the site etc.

Bathing waters where sampling frequency was not satisfied can still be quality assessed if at least four samples per season (three samples if the season does not exceed eight weeks or the region is subject to special geographical constraints) are available and equally distributed throughout the season. Assessment of bathing water quality is possible when the bathing water sample dataset is available for four consecutive seasons. Bathing waters are accordingly classified to one of the bathing water quality classes (excellent, good, sufficient, or poor).

The classification is based on pre-defined percentile values for microbiological enumerations, limiting the classes given in Annex I of the Directive. The Directive defines different limit values for coastal and inland waters.

Quality assessment is not possible for all bathing waters. In these cases, they are instead classified as either:

- not enough samples<sup>8</sup>;
- new<sup>9</sup>;
- changes<sup>10</sup>;
- closed<sup>11</sup>.

## 3. Bathing water quality

The results of the bathing water quality in Slovakia throughout the past period are presented in Figure 2. The previous reports are available on the European Commission's bathing water quality website<sup>12</sup> and the European Environment Agency's bathing water website<sup>13</sup>.

#### 3.1 Coastal bathing waters

There are no coastal bathing waters in Slovakia.

#### 3.2 Inland bathing waters

87.9% of all existing inland bathing waters were of at least sufficient water quality in 2016. See Appendix 1 for numeric data.




Figure 1: Inland bathing water quality trend in Slovakia. Note: the "At least sufficient" class also includes bathing waters of "Excellent" quality class, the sum of shares is therefore not 100%.

### 4. Information regarding management and other issues

Bathing water management in Slovakia includes establishing monitoring calendar, bathing water monitoring, assessing bathing water quality, identifying and assessing cause of pollution that might affect bathing waters and impair bather's health, giving information to the public, taking action to prevent bather's exposure to pollution, establishing a bathing water profile which is available on Public Health Authority of the Slovak Republic website:

In 2016, Public Health Authority monitored the quality of 30 bathing waters. Due to reconstruction (reduced water level, complete draining of water from the dam accumulations due to dam renovation) the following locations were closed throughout the season: Kunovska priehrada (SKREK008), Dolno Hodrušské jazero (SKREK010), Veľké Richnavské jazero (SKREK013).

### 5. Bathing water quality assessment presentation in online viewers

The European bathing water legislation focuses on sound management of bathing waters, greater public participation and improved information dissemination. The bathing water section of the Water Information System for Europe (WISE) which is accessible at the EEA bathing water website (<u>http://www.eea.europa.eu/themes/water/interactive/bathing/state-of-bathing-waters</u>) allows users to view the bathing water quality at more than 21 000 coastal and inland sites across Europe. The WISE bathing water quality data viewer combines text and graphical visualisation, providing a quick overview of the bathing water's locations and achieved quality. Having access to bathing water information, citizens are encouraged to make full use of it and participate with their comments.


